

# Updates to CSI New Account Console (NAC) Global Documents

## Field additions/modifications

IMM and CSI recognized that documents being generated from NAC based on the Global Forms posed certain challenges to the automated template recognition process in eSign. Working together, IMM and CSI have been able to determine necessary updates and CSI has made those updates to the Global Forms. Some IMM/eSign clients are utilizing the Document Designer to facilitate the management of documents being sent from CSI to eSign, but with these changes, that activity may no longer be necessary.

The Global Forms that CSI updated are listed below along with the changes made. To take advantage of these updates and reduce, or eliminate, the need for employees to use Document Designer, updates will need to be made to existing eSign Templates.

The information below lays out the forms that have been updated by CSI and a brief description of the updates made. It should help guide you in determining which templates your institution may need to update and what updates need to be made.

In most cases, "Party" (signer name(s)) have been added to the document in a useful location (generally near or under the signature line). In those cases, your eSign Document Administrator will utilize Template Manager to either add or alter the existing Party extraction information on the templates being used for the improved Global Form. It is likely that the current Party extraction is a static value (e.g., "Payee/Originator" on the ACH DEBIT STOP-PAYMENT REQUEST). Now you'll be able to upload a NEW sample for the template with an actual name (test data only) under the Authorized Signature line and select it instead for the Party Name.

In several cases, a signature date field has been removed from the form. The Provide Signature Date option can now be added to the Signature field.

And in a very few cases, a new or revised, index field has been added or amended on the form and in those cases your eSign Document Administrator will add or adjust the current index extraction field.

These changes should significantly reduce, or eliminate your employees' need to utilize the Document Designer during Session processing.
